Two-Way Referral Discount

What –

- This program awards a current MVLS family with a discount for each new student that is referred to MVLS for enrollment and is successfully enrolled.
- The referred family receives a discount for each student enrolled.
- Both families’ discounts are pro-rated per each student referred for the remainder of the current school year and valid enrollment.
- The referring family must be listed as such by the referred family on applicable paperwork.
- This is a “stackable” discount for the families; however, discounts may not exceed the balance due by either family. (i.e. Families will not receive monies back.)
- Discounts apply only to current academic year.

Who is/is not eligible –

- All current families of a MVLS student, who are current in tuition payments when the discount is applied, are eligible.
- Employees are not eligible.

For how long –

- Offer expires at the conclusion of the school year for which the new student enrolls; does not carry over into the next school year; and cannot be used to cover re-enrollment costs for current families.

Who can be referred –

- The offer applies only to new applicants for enrollment that have never been enrolled at MVLS (Preschool – grade 5).
- Siblings of current MVLS students and former MVLS students do not qualify for the program.

When/How the Discount will be awarded –

- Referral discounts are not transferrable to other families.
- Referring families receive their discounts as soon as the referred family is fully enrolled (e.g. financial account established, registration paperwork processed, and the like).
- The offer is valid only in so much as the referred family is enrolled for the entirety of the month for which the discount is applied. The referred family must also be in good, financial standing with the school for the referring family to be awarded the discount.
- If multiple families referred the same student, the discount will be applied in an equal share to all referring families as listed on the Registration paperwork.
- The discount policy assumes a 10-month calendar; application of said policy is done on a pro-rated basis.
- Refer to the Referral Discount Worksheet for details, allowing Office Staff to indicate in writing the actual amounts.

Admissions criteria –

- The regular enrollment criteria (testing, age, etc.) must be met by the new student.
- This program is subject to enrollment restrictions.
- This program is subject to re-evaluation, revision and revocation by MVLS at any time.

Elementary (A) refers Elementary (B)

A: \$100/month for up to 10 months off Tuition

B: One-time \$300 credit on Registration Fee

Elementary: Up to \$100/month for up to 10 months off Tuition, depending upon in which program the Preschool child is enrolled (1/5 for each day enrolled)

Preschool: One-time \$100 credit on Registration Fee

Preschool (G) refers Preschool (H)

G: One-time \$150 credit on tuition

H: One-time \$100 credit on either (Circle.): Registration Fee or Tuition

Preschool refers Elementary

Preschool: One-time \$150 credit on tuition

Elementary: One-time \$300 credit on Registration Fee
